## Conditions of Hire

1. Payment is strictly in advance when booking the items hired.
2. A deposit is payable, which is fully refundable if the equipment is returned in the same condition as you received it, that is, cleaned and packed.
3. Loss of deposit will result if
  - Equipment is returned DIRTY, WET and MUDDY
  - Equipment is returned late (or additional hiring fee will be charged)
  - Deposit claims will be lost if not done within 24 hours of the return of item hired.
4. Please do not leave or use the equipment in the rain, pack it up after use, store under shelter.
5. No eating, drinking, sharp objects or shoes are allowed on the equipment.
6. No person over the age of 12 years allowed on equipment unless otherwise stated, that is, adults on ADULT JUMPING CASTLES AND SLIDES only.
7. Please do not allow children to sit, climb or hang on the side walls.
8. In the event of a cancellation, a rain date voucher is given.
9. Use of equipment is entirely at lessee's own risk and must at all times be under adult supervision.
10. Only foam bath is to be used on splash and water slides.
11. Provide a suitable area for equipment, away from objects and preferably on grass and in the shade.
12. No persons are to play with or around the motor.
13. For popcorn machines, candy floss machines, sky dancers and helium please follow operating and cleaning instructions given.
14. Client is to check that the equipment is connected to an earthed power supply.

### Hardware and deposits

1. 25m extension cords are available for hire at R50.00 per day
2. Heavy duty pegs to secure the jumping castle are available at a refundable deposit of R50 for 4 pegs
3. Refundable deposit security deposit is R200.00 per item hired.

The lessee agrees to compensate TONY MILLER PROMOTIONS for the following should they arise.

- a) Cost of repair/replacement of equipment for loss or damage caused intentionally, recklessly, and/or negligently whilst the equipment is under the hire to the lessee (e.g knife wounds, torn stitching and material due to adults on the equipment etc).
- b) Cost of replacement of lost or stolen equipment whilst equipment is under hire to the lessee.
- c) Loss of income incurred whilst the equipment is under repair or being replaced as a result of damages or loss caused in terms of (a) or (b) above.
